The functions of the Committee shall be :-

- (a) To see whether District/Local Committees have been formed.
- (b) To see whether the meeting is held regularly at quarterly interval.
- (c) To see whether the authorized Officers are effectively performing their duties.
- (d) To see how many cases are handled by them and what decisions are arrived at.
- (e) To give suggestions /guidelines to district/local level committee
- (f) To take decision on the matter referred to it by District/Local level Committees.
- (g) To collect data/information from Distt./Local level Committees and forward it to Ministry of Health & Family Welfare, Govt. of India from time to time.
- (h) To recommend and initiate action in specific cases of violation of section-5 of the Indian Tobacco Control Act brought to the notice of the Committee.
- (i) To set in place a mechanism for reporting of violations including starting quit lines /tobacco help lines.
