



GATS Objectives

The Global Adult Tobacco Survey (GATS) is the global standard for systematically monitoring adult tobacco use (smoking and smokeless) and tracking key tobacco control indicators.

GATS is a nationally representative survey, using a consistent and standard protocol across countries, including India. GATS enhances countries' capacity to design, implement and evaluate tobacco control programs. It will also assist India to fulfill their obligations under the World Health Organization (WHO) Framework Convention on Tobacco Control (FCTC) to generate comparable data within and across countries. The WHO has developed MPOWER, a technical assistance package of six evidence-based policies that include:



- M**onitor tobacco use and prevention policies
- P**rotect people from tobacco smoke
- O**ffer help to quit tobacco use
- W**arn about the dangers of tobacco
- E**nforce bans on tobacco advertising, promotion, and sponsorship
- R**aise taxes on tobacco.

GATS Methodology

GATS uses a global standardized methodology. It includes information on respondents' background characteristics, tobacco use (smoking and smokeless), cessation, second-hand smoke, economics, media, and knowledge, attitudes and perceptions towards tobacco use. In India, GATS was conducted in 2009-2010 as a household survey of persons 15 years of age and older by the International Institute for Population Sciences (IIPS), under the coordination of the Ministry of Health and Family Welfare (MoHFW).

A nationally representative probability sample was used to provide national and six regional estimates by residence (urban and rural) and gender, as well as state estimates by gender. Survey information was collected using handheld devices. This fact sheet represents the state of Chhattisgarh in India. The estimates were based on 2,064 completed interviews of males and females in Chhattisgarh with an overall response rate of 91.3%.

GATS Highlights

Tobacco Use

- Current tobacco use in any form: 53.2% of adults; 63.9% of males and 41.6% of females.
- Current tobacco smoking: 12.6% of adults; 20.9% of males and 3.7% of females.
 - Current cigarette smoking: 5.7% of adults; 7.7% of males and 3.5% of females.
 - Current bidi smoking: 9.5% of adults; 15.0% of males and 3.5% of females.
- Current users of smokeless tobacco: 47.2% of adults; 52.5% of males and 41.6% of females.
- Average age at daily initiation of tobacco use: 17.3 years in adults, 17.6 years in males, and 16.1 years in females.
- 76.1% of daily tobacco users consume tobacco within half an hour of waking up.

Cessation

- 34.4% of current smokers and 35.0% of users of smokeless tobacco planned to quit or thought about quitting.
- 37.6% of smokers and 30.1% of users of smokeless tobacco were advised to quit by a health care provider.

Second-hand Smoke

- 67.1% of adults were exposed to second-hand smoke at home.
- 21.9% of adults were exposed to second-hand smoke in public places.

Media

- Adults who noticed any advertisement or promotion: 32.0% for cigarettes, 77.8% for bidis, and 81.4% for smokeless tobacco.
- Current users of the following tobacco products who thought about quitting because of a warning label: 32.2% for cigarettes, 14.2% for bidis, and 36.1% for smokeless tobacco.

Knowledge, Attitudes & Perceptions

- 85.2% of adults believe smoking causes serious illness.
- 79.0% of adults believe exposure to tobacco smoke causes serious illness in non-smokers.
- 86.5% of adults believe smokeless tobacco use causes serious illness.
