


Percent distribution of adults by tobacco use, Haryana 2016-17



About GATS

The Global Adult Tobacco Survey (GATS) is a global standard for systematically monitoring adult tobacco use (smoking and smokeless) and tracking key tobacco control indicators.

GATS is a household survey of persons 15 years of age and older conducted in all 30 states of India and two Union Territories. The first round of GATS was conducted between June 2009 and January 2010. The second round of GATS was conducted between August 2016 to February 2017 by Tata Institute of Social Sciences (TISS), Mumbai for Ministry of Health & Family Welfare (MoHFW), Government of India. A multi-stage sample design was used for both rounds of GATS. From each of the sampled households, one household member 15 years of age and older was randomly selected for individual interview. In Haryana, a total of 991 males and 1514 females were interviewed during August September 2016.



GATS 2 Highlights

- 33.1% of men, 4.8% of women and 19.7% of all adults currently smoke tobacco.
- 10.0% of men, 2.2% of women and 6.3% of all adults currently use smokeless tobacco.
- 39.1% of men, 6.3% of women and 23.6% of all adults either smoke tobacco and/or use smokeless tobacco.
- From GATS 1 to GATS 2, the prevalence of smoking and smokeless tobacco has remained unchanged. The prevalence of any tobacco use has also remained at 23.6, same as in GATS 1.
- *Bidi* and *hukkah* are the two most commonly used tobacco products. 15.5% and 7.6% of adults smoke *bidi* and *hukkah* respectively.
- The prevalence of tobacco use among persons aged 15-17 has increased from 0.0% in GATS 1 to 4.0% in GATS 2.
- The mean age at initiation of tobacco use has increased from 18.0 years in GATS 1 to 19.3 years in GATS 2.
- 55.0% of smokers were advised by a health care provider to quit smoking and 46.6% of smokeless tobacco users were advised by a health care provider to quit smokeless tobacco use.
- 52.9% of all adults who worked indoors were exposed to second-hand smoke at their workplace.
- 32.6% of all adults were exposed to second-hand smoke at any public place⁷.
- 40.4% of cigarette smokers and 57.2% of *bidi* smokers thought of quitting smoking because of warning label. 64.6% of smokeless tobacco users thought of quitting smokeless tobacco use because of warning label.








Age at initiation of tobacco use, smoking and smokeless tobacco use, GATS Haryana, 2009-10 and 2016-17 (mean age in years)





Percent distribution of adults by tobacco use status, GATS Haryana 2016-17




Prevalence of most commonly used tobacco products among all adults, GATS Haryana 2016-17 (Figures in Percentages)






Percent distribution of daily tobacco users by time to first tobacco use of the day, GATS Haryana 2016-17
