sub: Constitution of 'Anti-Narcotics Cell' - Reg.

It is stated that there are some general observations and inputs received from the public across Puducherry that the abuse of narcotic drugs is severe in the educational institutions including higher and professional educational institutions. The community support is highly required to put an end to the drug abuse in the premises of the educational institutions in order to identify the drug abusers, to track the peddlers and to apprehend them in time. In order to realise this objective, it is suggested to constitute an 'ANTI-NARCOTIC CELL (ANC)' in all the educational institutions with atleast 10 members, which includes 4 male students, 4 female students and 2 teaching/management staff. More students may also be included according to the need of the institution.

- 2. These ANCs are supposed to conduct awareness programmes inside the institution and in the immediate neighbourhood areas as communal social responsibility, for which necessary support will be extended from the Anti-Narcotics Task Force (ANTF) of Puducherry Police and the local SHO of the Police Stations. A separate social media platform (WhatsApp Group) can be created for communication by the educational institution involving the jurisdictional Superintendent of Police, Circle Inspector, SHO of the Police Station and ANTF Officers.
- 3. Further, the ANCs shall share the information with the local SHO as well as the ANTF Officers regarding drug abusers and peddlers found nearby the institution or at the premises or the neighbourhood areas. The identity of the informants will not be disclosed. The information thus received will be developed into an actionable intelligence; so that the peddlers concerned would be apprehended easily and quickly by the Police. Efforts will be taken to admit the drug abusers in the De-addiction Centres.
