Dated Shillong, the 10 November, 2020.

No.EKJ.20/5/2009/98:- It has been brought to the notice of the undersigned that vendors, stalls and other shop keepers are selling cigarettes and other tobacco products to minors at market places and within the proximity of Educational Institutions openly and in complete violation of section 6 of the Cigarettes and Other Tobacco Products Act, 2003 (COTPA) which prohibits sale of tobacco products to minors, i.e below the age of 18 years.

Further, the Department of Health and Family Welfare, Government of Meghalaya has issued Notification No.Health.101/2008/278, dated 26th June, 2019 in the interest of the public which clearly states that:-

- 1. As per Section 4 of COTPA 2003, no person shall smoke in any public place. "Public Place" means any place to which the public has access, whether as matter of right or not, and includes auditorium, hospital buildings, railway waiting room, amusement centres, restaurants, public offices, court buildings, educational institutions, libraries, public conveyances and the like which are visited by general public.
- 2. As per Section 6 of COTPA 2003, no person shall sell, offer for sale, or permit sale of, cigarette or any other tobacco product:-
  - (a) To a person who is under eighteen years of age.
  - (b) In an area within a radius of 100 yards of any educational institution.

In view of the above, the Undersigned hereby prohibits the following:-

- (i) Smoking in public places which means any place to which the public has access, which includes but is not limited to the places enumerated at (1) above.
- (ii) Sale of cigarettes and other tobacco products to any person who is under eighteen (18) years of age.
- (iii) Sale of cigarettes and other tobacco products in an area within a radius of 100 yards of any educational institution.

In addition to the prohibitions listed above, the undersigned do hereby direct the following:-

- (i) All Heads of Departments, Managers, Principals, etc must display "No Smoking" signage as specified under the Act in the respective offices or premises.
- (ii) Vendors, stalls and other shops where tobacco products are sold shall display a notice containing
- "Sale of cigarettes and other tobacco products to a person under the age of eighteen years is strictly prohibited and is a punishable offence".
- (iii) Any person who contravenes the provisions of section 6 shall be guilty of offences under this Act and shall be punishable with the imposition of fines and other prescribed penalties.
- (iv) Any violation of this Act is a punishable offence.
- (v) Law enforcement authorities/authorised Personnel will monitor the implementation and violation of the Act.

This order will come into force with immediate effect and until further orders.
